Often referred to as the "Lost City of the Incas", Machu Picchu is one of the most iconic symbols of the Inca civilization and a major archaeological site in the Americas. Built around 1450, it is believed to have served as an estate for the Inca emperor Pachacuti, though no contemporary written records exist to confirm this. The Historic Sanctuary of Machu Picchu is a protected area in Peru covering over 35,000 hectares. It includes the natural environment surrounding the Machu Picchu archaeological site, located in the rugged cloud forest of the Yungas on the eastern slope of the Peruvian Andes and along both banks of the Urubamba River, which flows northwest in this section.

This unique protected area encompasses one of the most extraordinary altitudinal transects in Peru, spanning only about twenty kilometers and protecting diverse ecosystems ranging from eternal snows at over 4,000 meters above sea level to tropical rainforests just over 1,700 meters above sea level.

Huayna Picchu, Quechua: Wayna Pikchu, is a mountain in Peru around which the Urubamba River bends. It is located in the Cusco Region, Urubamba Province, Machupicchu District. It rises over Machu Picchu, the so-called Lost City of the Incas. The Incas built a trail up the side of the Huayna Picchu and constructed temples and terraces at its top. The peak of Huayna Picchu is 2,693 metres (8,835 ft) above sea level, or about 260 metres (850 ft) higher than Machu Picchu.

According to local guides, the top of the mountain was the residence for the high priest and the local virgins. Every morning before sunrise, the high priest with a small group would walk to Machu Picchu to signal the coming of the new day. It is the third highest railway in the world after the Qinghai—Tibet Railway to Tibet and the FCCA line from Lima to Huancayo, and is the longest line in Peru.

From Cusco, PeruRail provides passenger services on the 3 ft (914 mm) gauge Ferrocarril Santa Ana to Aguas Calientes, delivering tourists for Machu Picchu.

The Peru–Yale University dispute was a century-long conflict between the government of Peru and Yale University about the rightful ownership of Inca human remains and artifacts from Machu Picchu, an ancient Inca site high in the Peruvian Andes active c. 1420–1532. In the several years following his re-discovery of Machu Picchu in 1911, Yale explorer Hiram Bingham III removed thousands of objects – including pottery, stone tools, and human bones – from the archaeological site and brought them to New Haven, Connecticut. The circumstances of these transfers were disputed, with some, including Bingham, claiming that Yale agreed to borrow the artifacts for a period of 18 months to conduct studies. Peru attempted to regain the collection in the 1920s, but Yale resisted. Tensions rose between 2006...

Hiram Bingham III (November 19, 1875 – June 6, 1956) was an American academic, explorer and politician. In 1911, he publicized the existence of the Inca citadel of Machu Picchu which he rediscovered with the guidance of local indigenous farmers. Later, Bingham served as the 69th Governor of Connecticut for a single day in 1925—the shortest term in history. He had been elected in 1924 as governor, but was also elected to the Senate and chose that position. He served as a member of the United States Senate until 1933.

Casa Concha is a colonial-era house located in Cusco, Peru. Its name is attributed to one of its former owners, possibly Martín de la Concha y Jara, governor and intendant of Cusco around 1812, his descendant Martín Concha y Cámara, or even José Santiago Concha y Salvatierra, Marquess of Casa Concha.

Since 1972, the building has been part of the Monumental Zone of Cusco and was declared a Historic Monument of Peru. In 1983, as part of Cusco's historic center, it was included in the UNESCO World Heritage Site listing.
