Lawyers' Movement

The Lawyers' Movement (Urdu: وکالا کی تحریک, romanized: Wakala ki Tahrik), also known as the Movement for the Restoration of Judiciary or the Black Coat

The Lawyers' Movement (Urdu: وکالا کی تحریک, romanized: Wakala ki Tahrik), also known as the Movement for the Restoration of Judiciary or the Black Coat Protests, was the popular mass protest movement initiated by the lawyers of Pakistan in response to the former president and army chief Pervez Musharraf's actions of 9 March 2007 when he unconstitutionally suspended Iftikhar Muhammad Chaudhry as the chief justice of Pakistan's Supreme Court. Following the suspension of the chief justice, the Supreme Court Bar Association (SCBA) declared the judge's removal as an "assault on the independence of judiciary" and was backed by several political parties.

The National Lawyers Guild (NLG) is a progressive public interest association of lawyers, law students, paralegals, jailhouse lawyers, law collective members, and other activist legal workers in the United States. The group was founded in 1937 as an alternative to the American Bar Association (ABA), in protest of the organization's then exclusionary membership practices and conservative political orientation. They were the first predominantly white US bar association to admit minorities to their ranks. The group sought to bring more lawyers closer to the labor movement and progressive political activities (e.g., the Farmer–Labor Party movement), to support and encourage lawyers otherwise "isolated and discouraged", and to help create a "united front" against fascism.

The organization called on the private bar to bring its resources to bear on the major civil rights problems beleaguering the nation; some of its earliest leaders included Bernard G. Segal, Harrison Tweed, Lloyd Cutler, Cecil Burney, Berl Bernhard, and John Doyle. During a historic June 21, 1963 meeting at the White

A fork end, fork-end, or forkend is a slot in a bicycle frame or bicycle fork where the axle of a bicycle wheel is attached. A dropout is a type of fork end that allows the rear wheel to be removed without first derailing the chain.

Track bicycle frames have track fork ends, on which the opening faces rearwards. Because they do not have dropouts, the chain must be derailed from the sprocket before the rear wheel can be removed from a typical track bike. Some single-speed bicycles intended for street or trail use are also equipped with track fork ends instead of dropouts.

On bicycles that do not have a derailleur or other chain tensioning device, rear horizontal dropouts allow adjustment of chain tension, and can accommodate a range of chain lengths or cog sizes. They were standard on most...
