## What's Wrong with Postmodernism

In *What's Wrong with Postmodernism* Norris critiques the "postmodern-pragmatist malaise" of Baudrillard, Fish, Rorty, and Lyotard. In contrast he finds a continuing critical impulse--an "enlightened or emancipatory interest"--in thinkers like Derrida, de Man, Bhaskar, and Habermas. Offering a provocative reassessment of Derrida's influence on modern thinking, Norris attempts to sever the tie between deconstruction and American literary critics who, he argues, favor endless, playful, polysemic interpretation at the expense of systematic argument. As he explores leftist attempts to arrive at an accommodation with postmodernism, Norris addresses the politics of deconstruction, the issue of men in feminism, Habermas' quarrel with Derrida, narrative theory as a hermeneutic paradigm, musical aesthetics in relation to literary theory, and various aspects of postmodern debate. A chapter on Stanley Fish brings several of these topics together and offers a generalized statement on the function of current criticism.

## **All Hail the Death of Truth! the Advent of the Postmodern Era**

Bruce A. Proctor is a native of Dallas, Texas but spent most of his youth growing up in Los Angeles, California. He graduated from Oklahoma Christian College (B.A.) in 1973, from Dallas Theological Seminary (Th.M.) in 1981, and Louisiana Baptist University (Ph.D.) in 2011. Bruce has held various ministerial positions including pastor, youth counselor and pastor, prison ministry leader, and college professor. Bruce has taught Bible Exposition, Theology, Old and New Testament history, and Church History at various Christian schools - Southern Bible Institute, D. Edwin Johnson Bible Institute (both in Dallas, TX), True Vine Baptist Bible Institute in Spencer, OK, and at the Ministry Training Institute, an extension of Oklahoma Baptist University in Shawnee, OK. Bruce and his wife, Patricia, reside in San Antonio, Texas. They have eight adult children. Postmodernism is difficult to define because it rejects absolute meaning. However, I found it worth trying to define it by looking at other authors' attempts to define it. It was easier for me to describe than define it. Much discussion is also given to the definition of the emergent church movement, including its fundamental tenets and marks, along with signs of drifting toward it. Next, the idea of postmodernism is weaved into the description of condemned mankind according to Romans 1:18-32. The description given is clearly relevant to the postmodern mindset as \"men, who suppress the truth in unrighteousness\" (verse 18). In my conclusion, I discuss the power of truth and the loss of truth due primarily to a loss of focus. However, in the Person of Jesus Christ, Truth arose from the dead and marches on victoriously despite the postmodern spirits of delusions.

## **The Postmodern**

Christopher Hitchens was the most eloquent of the New Atheists. With great rhetorical polish and an encyclopedic mind for historical facts and literary quotations, he presents the case of anti-theism very effectively. Though now deceased, Hitchens' arguments continue to reverberate through his best-selling books and online presence. God, asserts Hitchens, would be, if he existed, the greatest of dictators. Religion, according to Hitchens, is morally bankrupt and madly irrational. The world is better off without them! But is this true? It is the purpose of this book to identify Hitchens' worldview in order to subject it to a critique that will powerfully expose its many flaws. Rather than a dictator, God will be shown to be a God of love. Christianity too will be revealed as a faith that ought to resist tyranny, provides the best foundation for intrinsic human value, and is a rational belief-system. In so doing, this book appeals to all who have been

influenced or convinced by Hitchens' arguments to reconsider their position and refuse to rage against the light.

Marxism continues to provide critical tools for articulating productive conflict within the postmodernism debates, advancing of strategies of critique beyond identity politics toward a more self-reflective ideological discussion of the multiple axes of power and oppression in political struggles over democracy. In this unique study, complex philosophical issues are described lucidly and their relevance for today is established compellingly.

## **The Postmodern**

This book examines the relationship between nihilism and postmodernism in relation to the sublime, and is divided into three parts: history, theory, and praxis. Arguing against the simplistic division in literary criticism between nihilism and the sublime, the book demonstrates that both are clearly implicated with the Enlightenment. Postmodernism, as a product of the Enlightenment, is therefore implicitly related to both nihilism and the sublime, despite the fact that it is often characterised as either nihilistic or sublime. Whereas prior forms of nihilism are 'modernist' because they seek to codify reality, postmodernism creates a new formulation of nihilism - 'postmodern nihilism' - that is itself sublime. This is explored in relation to a broad survey of postmodern literature in two chapters, the first on aesthetics and the second on ethics. It offers a coherent thesis for reappraising the relationship between nihilism and the sublime, and grounds this argument with frequent references to postmodern literature, making it a book suitable for both researchers and those more generally interested in postmodern literature.

## **Marx and the Postmodernism Debates**

The Passing of Postmodernism addresses the increasingly prevalent assumption that a period marked by poststructuralism and metafiction has passed and that literature and film are once again engaging sincerely with issues of ethics and politics. ## **Christianity and the Postmodern Turn**

crusade to secure political and ideological dominance of the landscape of American biblical scholarship. The Albright School constituted a sociological phenomenon that had lasting consequences for American intellectual history and scholarship. Accordingly, this book suggests ways in which Albright, or a social realization of Albright, was present in, and presented to, a culture of generational and ideological solidarity.

## **Postmodernism. What moment?**

*Time and Commodity Culture* is a set of four linked essays on the cultural systems of postmodernity. Rather than taking modernity and postmodernity as real historical epochs, however, it understands them as strategies for organizing time and social order by means of a 'nostalgic' division within them. Each essay explores a particular dimension of this organization of time, especially in relation to the anxieties and the possibilities created by the commodification of culture. The central essay, 'Gift and Commodity', studies two areas in which the speed of commodification has increased markedly in recent years: That of the person, and that of information. Using a mix of anthropological, legal, economic, and historical materials, it investigates the privatization of the commons in information by way of such things as the development of markets in human DNA, the trade in human organs, and the creation of property rights in 'personality'. 'What Was Postmodernism?' analyses the structured anxiety about the commodification of culture that is called 'postmodern theory'. A further essay explores tourism as a figure of modernity, and a final essay on memory explores the phenomena of 'recovered memory' and of Holocaust remembrance as ways of constructing

temporally ordered forms of the real.
