False color

False colors and pseudo colors respectively refers to a group of color rendering methods used to display images in colors which were recorded in the visible

False colors and pseudo colors respectively refers to a group of color rendering methods used to display images in colors which were recorded in the visible or non-visible parts of the electromagnetic spectrum. A false-color image is an image that depicts an object in colors that differ from those a photograph (a true-color image) would show. In this image, colors have been assigned to three different wavelengths that human eyes cannot normally see.

In addition, variants of false colors such as pseudocolors, density slicing, and choropleths are used for information visualization of either data gathered by a single grayscale channel or data not depicting parts of the electromagnetic spectrum (e.g. elevation in relief maps or tissue types in magnetic resonance imaging).

False Creek

False Creek (French: Faux ruisseau) is a short narrow inlet in the heart of Vancouver, separating the Downtown and West End neighbourhoods from the rest

False Creek (French: Faux ruisseau) is a short narrow inlet in the heart of Vancouver, separating the Downtown and West End neighbourhoods from the rest of the city. It is one of the four main bodies of water bordering Vancouver, along with English Bay (of which it is an inland extension), Burrard Inlet, and the Fraser River. Granville Island is located within the inlet.

Sir George Henry Richards named False Creek during his hydrographic survey of 1856–1863. While travelling along the south side of the Burrard Inlet, Richards thought he was traversing a creek; upon discovering his error, he gave the inlet its current name.

The inlet opens into the English Bay to its northwest, and is surrounded by the Downtown and West End neighbourhoods in the north, Strathcona in the east, and Mount Pleasant...

False flag

Similarly deceptive activities carried out during peacetime by individuals or nongovernmental organizations have been called false-flag operations, but

A false flag operation is an act committed with the intent of disguising the actual source of responsibility and pinning blame on another party. The term "false flag" originated in the 16th century as an expression meaning an intentional misrepresentation of someone's allegiance. The term was originally used to describe a ruse in naval warfare whereby a vessel flew the flag of a neutral or enemy country to hide its true identity. The tactic was initially used by pirates and privateers to deceive other ships into allowing them to move closer before attacking them. It later was deemed an acceptable practice during naval warfare according to international maritime laws, provided the attacking vessel displayed its true flag before commencing an attack.

False Dmitry II (Russian: ?????????? II, romanized: Lzhedmitrii II; died 21 December [O.S. 11 December] 1610), historically known as Pseudo-Demetrius

False Dmitry II (Russian: ?????????? II, romanized: Lzhedmitrii II; died 21 December [O.S. 11 December] 1610), historically known as Pseudo-Demetrius II and also called tushinsky vor ("the thief of Tushino"), was the second of three pretenders to the Russian throne who claimed to be Tsarevich Dmitry Ivanovich, the youngest son of Ivan the Terrible, during the Time of Troubles. The real Dmitry had died under uncertain circumstances, most likely an assassination in 1591 at the age of nine at his widowed mother's appanage residence in Uglich.

The second False Dmitry first appeared on the scene around 20 July 1607, at Starodub. He is believed to have been either a priest's son or a converted Jew, and was relatively highly educated for the time. He spoke both the Russian and Polish languages and...

In Marxist theory, false consciousness is a term describing the ways in which material, ideological, and institutional processes are said to mislead members of the proletariat and other class actors within capitalist societies, concealing the exploitation and inequality intrinsic to the social relations between classes. As such, it legitimizes and normalizes the existence of different social classes.

According to Marxists, false consciousness is consciousness which is misaligned from reality. Thus, it is a serious impediment to human progress and correcting it is a major focus of dialectical materialism.

False imprisonment

individual has been, is, or is about to be engaged in a criminal activity. To prevail under a false imprisonment claim, a plaintiff must prove: Willful detention

False imprisonment or unlawful imprisonment occurs when a person intentionally restricts another person's movement within any area without legal authority, justification, or the restrained person's permission.

Actual physical restraint is not necessary for false imprisonment to occur. A false imprisonment claim may be made based upon private acts, or upon wrongful governmental detention.

For detention by the police, proof of false imprisonment provides a basis to obtain a writ of habeas corpus.

Under common law, false imprisonment is both a crime and a tort.

False pregnancy

False pregnancy (or pseudocyesis, from Ancient Greek *pseudes* 'false' and *kyesis* 'pregnancy') is the appearance of clinical or subclinical signs and symptoms associated with pregnancy although the individual is not physically carrying a fetus. The mistaken impression that one is pregnant includes signs and symptoms such as tender breasts with secretions, abdominal growth, delayed menstrual periods, and subjective feelings of a moving fetus. Examination, ultrasound, and pregnancy tests can be used to rule out false pregnancy.

False pregnancy has a prominent psychiatric component as well as physical manifestations of pregnancy. It can be caused by trauma (either physical or mental), a chemical imbalance of hormones, and some medical

conditions. Contributing psychological factors include a strong...

False Bay (Afrikaans: Valsbaai) is a body of water in the Atlantic Ocean between the mountainous Cape Peninsula and the Hottentots Holland Mountains in the extreme south-west of South Africa. The mouth of the bay faces south and is demarcated by Cape Point to the west and Cape Hangklip to the east. The north side of the bay is the low-lying Cape Flats, and the east side is the foot of the Hottentots Holland Mountains to Cape Hangklip which is at nearly the same latitude as Cape Point. In plan the bay is approximately square, being roughly the same extent from north to south as east to west, with the southern side open to the ocean. A false confession is an admission of guilt for a crime which the individual did not commit. Although such confessions seem counterintuitive, they can

A false confession is an admission of guilt for a crime which the individual did not commit. Although such confessions seem counterintuitive, they can be made voluntarily, perhaps to protect a third party, or induced through coercive interrogation techniques. When some degree of coercion is involved, studies have found that subjects with low intelligence or with mental disorders are more likely to make such confessions. Young people are particularly vulnerable to confessing, especially when stressed, tired, or traumatized, and have a significantly higher rate of false confessions than adults. Hundreds of innocent people have been convicted, imprisoned, and sometimes sentenced to death after confessing to crimes they did not commit – but years later, have been exonerated. It was not until several...

A false awakening is a vivid and convincing occurrence in a dream where one experiences awakening from sleep, though in reality continues to sleep. It is mostly associated with another dream, however it may occur as its own. After a false awakening, subjects often dream they are performing their daily morning routine such as showering or eating breakfast. False awakenings, mainly those in which one dreams that they have awoken from a sleep that featured dreams, take on aspects of a double dream or a dream within a dream. A classic example in fiction is the double false awakening of the protagonist in Gogol's Portrait (1835).

Studies have shown that false awakening is closely related to lucid dreaming that often transforms into one another. The only differentiating feature between them is...
